WELP® 6.0 SOFTWARE END USER LICENSE AGREEMENT FOR DESKTOP USE ONLY

important: this software end user license agreement ("EULA") is a legal agreement between you and world emblem. Read it carefully before using the software. It provides a license to use the software and contains warranty information and liability disclaimers. By selecting the download or install now button and using the software, you are confirming your acceptance of the software and agreeing to become bound by the terms of this agreement. If you do not agree to be bound by these terms, then uninstall the software from your computer.

1. Definitions

(a) "World Emblem" means World Emblem Intl. and its licensors, if any.

(b) "Software" means only the WELP software program(s) and third party software programs, in each case, supplied by World Emblem herewith, and corresponding documentation, associated media, printed materials, and online or electronic documentation.

2. License Grants

(a) You may install and use the Software on a single desktop computer that has a Windows PC (including Windows 2000, and XP), desktop operating system; provided, however, that, notwithstanding anything contrary contained herein, you may not use the Software on any non-PC product, including, but not limited to, a web appliance, set top box (STB), handheld, phone, or web pad device. A license for the Software may not be shared, installed or used concurrently on different computers.

(b) You may make one copy of the Software in machine-readable form solely for backup purposes. You must reproduce on any such copy all copyright notices and any other proprietary legends on the original copy of the Software.

(c) You agree that World Emblem may audit your use of the Software for compliance with these terms at any time, upon reasonable notice.

(d) Your license rights under this EULA are non-exclusive.

(e) Certain rights are not granted under this Agreement, but may be available under a separate agreement.

3. License Restrictions

(a) Other than as set forth in Section 2; you may not make or distribute copies of the Software, or electronically transfer the Software from one computer to another or over a network.

(b) You may not alter, merge, modify, adapt or translate the Software, or decompile, reverse engineer, disassemble, or otherwise reduce the Software to a human-perceivable form.

No World Emblem dealer, agent or employee is authorized to make any amendment to this EULA.

WHAT'S NEW IN WELP VERSION 6.0:

- Print Queue Lists of designs sent to the printer
- **Image Preview** Every line on the queue will allow you to see the thumbnail image of the design when selected.
- **Purge from Queue** Ability to remove unwanted designs from queue. Just select one or multiple designs and delete them from the queue
- **Queue Priority** Ability to change the order of the designs in the queue to be printed.
- **Design Quantity** Quantities can be edited directly inside of the queue.
- **3 Lines for Name Dropper** Ability to print up to three lines of text on your name dropper design.
- **Print Border Information** By turning the Border Information "ON" a caption with the border color name will be printed next to each design.
- Printable Daily Report A Print Report button allows you to print a list of all designs printed during the day. This list includes Time, Quantities, Design Number, Description and Size of the Emblem.
- Printer Settings Tab Quick access to the printer and printing options.
- Live Help Live chat feature with World Emblem's Sales Support Representatives to answer your questions.

PRINTING PERFECT PRINT EMBLEMS:

1. Once you log into your on-line World Emblem catalog, type the design description or design number of the Perfect Print emblem design that you would like to print into the Keyword Search box.



2. Click on the Perfect Print link shown.

4. A new window will appear showing the Design #, Description, Quantity and a thumbnail image of the design to be printed. Go back to Step 1 to add additional designs for printing. You also have the option to Remove, Remove All, Print, Print All or Print Report by selecting the buttons at the bottom. (See page 11 for instructions)

3. Output Printer: Click on the Select button to choose the printer that will be the default for the WELP 6.



- 4. **Printer Border Information:** Select the "ON" option. This will allow the WELP 6.0 to print the border information on every emblem that is sent to printer. The "OFF" option will eliminate this feature.
- 5. **Extended Header**: Select the "ON" option. This will allow the first design's number and size to be sent to the printer.
- 6. **Cache:** Cache folder contains temporary files created by the WELP. This folder can be easily cleaned by clicking the "Clear" button.

1. Go to Start > Printers & Faxes and right click on Epson 1400 printer icon and then select Printing Preferences. Once opened, click on Advanced.
